

Microsoft Online Services Subprocessors List

This list identifies the subprocessors authorized to access both (i) customer data and personal data contained within it in Microsoft's Online Services (referred to as "Customer Data" in the table below), as well as (ii) personal data other than that contained in Customer Data. Any such subprocessors will be permitted to process customer data or personal data only to deliver the services Microsoft has retained them to provide, and they are prohibited from using such data for any other purpose. These subprocessors (including their subsidiaries) may provide services to one or more of the online services. The list below may not apply to previews or other services not yet in general release.
